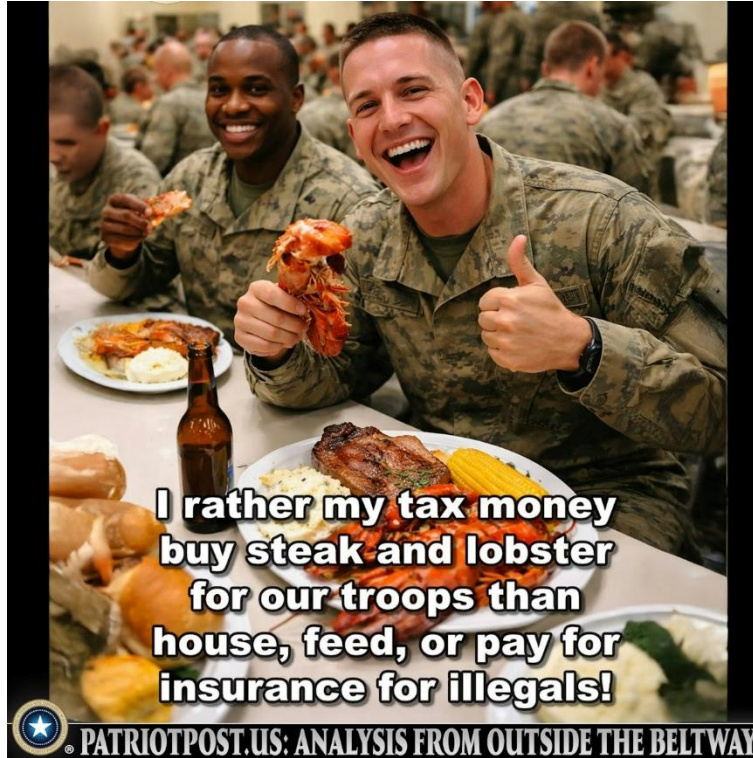

"Immigration in Maryland plunged 57% last year"

"Birthright Citizenship and the Supreme Court"

On April 1, the Supreme Court initiated the long awaited Birthright Citizenship case with 2 hours of oral arguments. This case is so important that President Trump attended the session, a Presidential first for the Supreme Court.

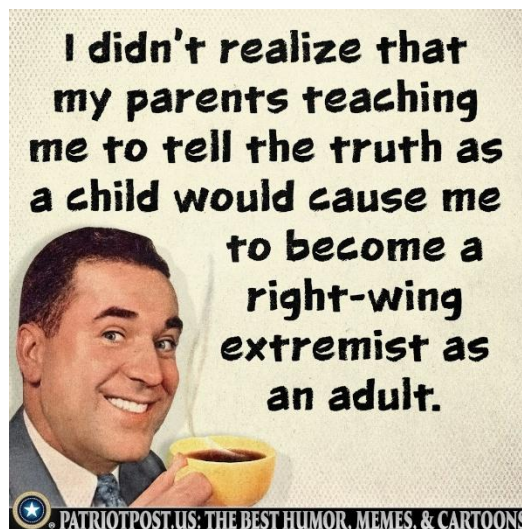
