**"CASA and their Brethren Pressure Moore - He Crumbles"**

**Below is a Press Release organized by CASA and their interesting band of like minded Crew members who pressured Moore into allowing the Community Trust Act to become law:**

**"ANNAPOLIS, MD — With the deadline to sign or veto legislation rapidly approaching at the end of the month, a coalition of leading national immigrant rights organizations has come together to urge Governor Wes Moore to sign the Community Trust Act (SB791) and the Data Privacy Act (HB711) into law without further delay. (NOTE - Even CASA and their Compadres expected Moore to sign or veto, not pull a disappearing act).**

**"In a new letter sent today to Governor Moore, 24 organizations call on him to sign the two bills approved by the state legislature last month, describing them as critical next steps to strengthen Maryland's defenses against the Trump administration's mass deportation and family separation agenda. The groups pointed to Moore's previous leadership in ending the state's 287(g) agreements and blocking ICE detention expansion, arguing these measures are more necessary than ever to cement Maryland's role as a national leader in immigrant and civil rights." (National Leader?)**

**"Just as advocates and families across the country have looked to states like Illinois and California for leadership, many are now looking to Maryland to help set the standard," wrote the organizations. (What?) "We urge you to continue leading Maryland — and the nation — by signing these bills into law."**

**"The Community Trust Act limits state and local law enforcement from colluding with ICE by requiring a judicial warrant for detention and restricting police from acting as ICE informants. The Data Privacy Act closes dangerous loopholes that have allowed ICE and private data brokers to access personal information from driver's records, school enrollment forms, and public benefit applications."**

**"Together, this legislative package delivers a powerful one-two punch: restoring trust between communities and law enforcement while shutting down the data pipelines being abused to target immigrant families. The Community Trust Act includes an emergency amendment, meaning it would take effect immediately upon the Governor's signature."**

**"Governor Moore has until the end of the month to act on the bills, which were delivered to his desk following a historic 2026 legislative session for immigrant and civil rights advocates in Maryland. Immigrant families and community members led the sustained advocacy campaign that secured passage of the bills, with more than 200 advocates mobilizing in Annapolis throughout the legislative session to rally, testify, and share their stories directly with policymakers."**

**"Maryland Sheriffs Sound off after Community Trust Act Becomes Law"**

**"Again, it's public safety. It's a danger for our community. It puts the state of Maryland in a status all by itself as an ultra sanctuary jurisdiction," Harford County Sheriff Jeff Gahler said.**

**"I believe it's unconstitutional. I don't believe that that state legislature can do it, and I think what you'll see next week is the sheriffs throughout the state look for injunctive relief or emergency relief for that, so that we can continue keeping our jurisdiction safe from this overreach of Annapolis," Carroll County Sheriff Jim DeWees said.**

"He should have vetoed it because he knows that it has severe risks of public safety throughout the state of Maryland," DeWees said.

Frederick County Sheriff Charles Jenkins said he believes the state will face consequences from the change. "I don't believe the governor or legislature has an idea of the damage they've done," Jenkins said.

Bottom line: The Sheriffs opposing this decision by Governor Moore stated they plan to file a lawsuit challenging it!

"Trump administration orders Green Card applicants to leave the US, apply from their home countries"

This is huge!

"U.S. Citizenship and Immigration Services (USCIS) announced on Friday a major shift in immigration policy, dictating that noncitizens in the U.S. who have applied for a green card, or lawful permanent resident status, must leave the country indefinitely — even if they are in the country legally and regardless of whether they have spouses or children with citizenship."

"Green card petitioners will then be required to wait for their application to be processed outside the country through consular processing via the U.S. Department of State."

"The Trump administration's position remains that when noncitizens travel into the country via student visas, tourist visas or temporary work status, they are supposed to leave once that term expires and that temporary permission to be in the U.S. should not serve as the first step toward getting a green card."

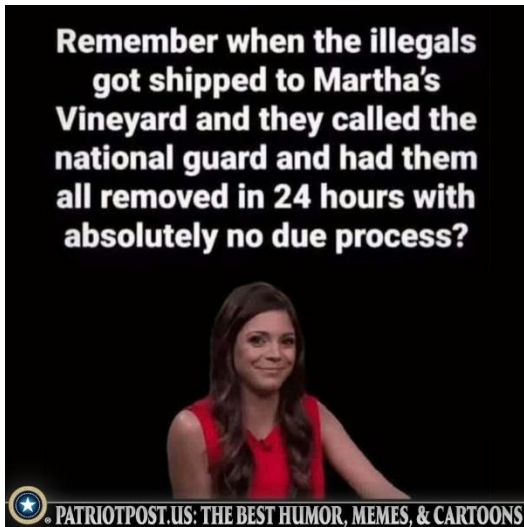
