WITH MOUNTAIN VIEW CHRISTIAN ACADEMY**

1. Though MVCA may obtain my written permission for school trips away from campus, I agree to allow the applicant to participate in all school activities. I further absolve the school from liability to me, or my child, because of injury, death or dismemberment to my child during a school sponsored activity. I further authorize the school to secure any necessary emergency medical treatment for my child in the event of an injury at school or on a school sponsored trip away from the school premises when parents cannot be contacted. Furthermore, if my child is hurt on the school property during the school day or during a school function, I realize that it is my responsibility to cover all doctor and hospital charges.
2. I realize that I am expected to pay my account on time. If I fail to pay by the tenth of each month, I must pay a late fee of \$10.00 per child. If I get two months behind, I understand my child will not be allowed to return to classes and will receive a zero for missed assignments until the bill is paid.
3. I realize the school building opens at 6:30 a.m. for preschool children **only**. Students may arrive after 8:00 a.m. and must be picked up by 4:00 p.m.
4. Before any medication is dispensed to my child at school, I will provide written authorization which includes: date, name of child, name of medication, dosage, date and time of day medication is to be given. Medicine will be in the original container with my child's name marked on it. All medication must be left in the office.
5. I acknowledge it is my responsibility to keep my child's records current to reflect any significant changes as they occur, e.g. telephone number, work location, emergency contacts, etc.
6. The administration has full responsibility for placing my child in the proper grade.
7. My cooperation is expected in: (a) regular tuition payments, (b) practical help and (c) faithful prayer.
8. The school reserves the right to dismiss any student who does not respect its spiritual standard or cooperate in the educational progress.
9. The school agrees to keep me informed of any incidents, including illnesses, injuries, adverse reactions to medications, or exposure to communicable diseases, which include my child.
10. In full cooperation with Mountain View Christian Academy, we will regularly attend the Parent-Teacher Fellowship meeting and other functions requiring our participation.

## MOUNTAIN VIEW CHRISTIAN ACADEMY DRUG TEST CONSENT FORM

All students in grades 9-12 at Mountain View Christian Academy are required to submit to drug testing via urinalysis. The test may be given to everyone at the beginning of the school year and administered randomly throughout the duration of the school year.

The drug test will reveal if any drugs are in the system of the student. If your student is currently using a drug prescribed by his/her physician, you should provide a copy of that prescription with this consent form.

You need not be concerned with legal, harmless substances showing up on the test results. Any tests that turn out positive will be subjected to definition analysis which will identify the exact substances. Students should not alter their eating habits in anticipation of the test. The day the test will be administered **will not** be announced in advance.

We administer drug testing at MVCA as a means of letting the community know that we take a serious stand against drug abuse. We seek to have a completely drug free school zone. Any students who are found to be using drugs will be dismissed from MVCA and no refunds will be given. Re-admission of such students will be subject to Board approval.

The result of these drug tests will be held in confidentiality. A parent has the right to know the results of one's student's drug test and will be shown those results upon request. If the student is found to be using drugs illegally, the parent will be notified.

Remember, the drug test is intended to give our students reinforcement in their ability to say "no" in the face of certain temptations. The drug test is intended to give struggling students an extra incentive to stay "clean." We love our students and care for them; hence, we want to keep them free from the cruel snares of drug addiction.

TUITION PAYMENT CONTRACT

In order to receive the “early bird” registration fee, the registration must be paid before the deadlines as follows:

**Registration Fee: \$125**

For student tuition accounts that are being paid according to the monthly installment plan, payments are due on the 1<sup>st</sup> of each month. A grace period is extended through the 10<sup>th</sup> of each month. After the 10<sup>th</sup>, a late fee of \$10.00 per child will be added to any unpaid accounts and notices will be sent home to the parents. If an account remains unpaid through the last day of the month, then the student will **not** be permitted to return to school until the account is brought current. Once dismissed, the student will be reported to the public school system for the area in which he/she lives. Parents will be required to appear before the school board after 45 days delinquent. If your student(s) withdraws after the 10<sup>th</sup> day of the month, you are responsible for that month’s tuition.

Your student(s) will not be allowed to re-register at Mountain View if there is an unpaid balance left on the account from the previous school year. The account **MUST BE** current before registration. This includes any outstanding late fees, lunch charges or any other unresolved fees or charges that might have been incurred on the account.

There is a \$30.00 NSF charge for all returned checks. After the second (2<sup>nd</sup>) consecutive check is returned on an account, we will only accept payments by cash, cashier’s check or money order. **It is imperative that tuition be paid in a timely manner as this is the primary source of funding for teacher salaries.**

## **MOUNTAIN VIEW CHRISTIAN ACADEMY STANDARDS OF CONDUCT**

Mountain View Christian Academy holds that the Bible is the infallible, divine Word of God and that salvation is through faith in Christ is the initial step in the Christian life. There is adequate Biblical basis for the idea of spiritual growth in the image of Christ (Romans 8:28), which is the work of the Holy Spirit (II Corinthians 3:18). This growth begins with the initial act of saving faith and continues throughout life. The Holy Spirit makes the Christian conscious of the Biblical demands for a Holy life which fulfills both God's moral law and high law of love (Matthew 22:37-39| Romans 13:8-10; Galatians 5:14). The result is a life consecrated unto God and separated from worldly activities

Mountain View Christian Academy must, therefore, provide an environment conducive to the spiritual growth and development of young people. A standard of conduct based on the following Biblical imperative is necessary to provide such an environment. All student activities and conduct must be subordinated to Biblical standards.

A sense of the need for spiritual growth in our students has led Mountain View Christian Academy to adopt the following standards which are conducive to the environment that will promote the spiritual welfare of all students. The Academy, therefore, expects each student—whether at home, school, or elsewhere:

1. To refrain from participating in or discussing of worldly activities such as swearing or indecent language; body piercing or tattoos; smoking, possession or use of alcoholic beverages, drugs or tobacco; involvement in the occult; stealing; pornography; premarital sex, homosexuality, wearing of certain apparel that would support gay, lesbian, or homosexual lifestyles or other perverted lifestyles.
2. The refrain from harassment, fighting, violence, or threats of any kind regardless of provocation; public disruptions or exhibitionism in any form; promoting division or a divisive spirit through symbols, pictures, writing, flags, banners, slogans, gang related items, or any divisive activism.
3. To maintain Christian standards in courtesy, kindness, honesty, morality, and dress.

Students are expected to abide by these standards throughout their enrollment, whether at home, school or elsewhere and regardless of whether or not school is in session. Students found to be out of compliance or harmony with Mountain View Christian Academy's Standards of Conduct will be subject to administrative withdrawal. Any student who has been arrested by public law enforcement authorities will be suspended until such a time as that student is adjudicated either

guilty or not-guilty. Any student who is adjudicated guilty will be transferred out of Mountain View Christian Academy.

Mountain View Christian Academy has open enrollment and therefore some of our students may not be Christian: however, our desire is to see all of our students to become Christians. Whether or not a student has made a personal decision to be a Christian, each student will be expected to abide by these standards of conduct and maintain Christian standards. Attendance at Mountain View Christian Academy is a privilege, not a right.
