



Waiver of Liability & Release Agreement 2024

By my signature below, I acknowledge that I am aware of, appreciate the character of, and voluntarily assume the risks involved in shooting sports and the participation in shooting sports events and/or the operation of firearms, all of which occur at the Pipestone Sportsmen’s Club in Pipestone MN. As a participant in shooting sports and being in a facility where shooting sports occur, I understand the inherent risks to my person and to others. When I participate in shooting sports at Pipestone Sportsmen’s Club in which firearms and equipment are used, I understand and am aware of the inherent and apparent risks of participating in the activity.

By my signature below, on behalf of myself, my heirs, next of kin, successors in interest, assigns, personal representatives, and agents, I hereby:

1. Waive any claim or cause of action against and release from liability Pipestone Sportsmen’s Club, it’s officers, volunteers, employees, event sponsors, independent contractors and agents for any liability for injuries to my person or property resulting from my participation in the activities above;
2. Agree to indemnity and hold harmless Pipestone Sportsmen’s Club, its officers, volunteers, employees, event sponsors, independent contractors and agents for any claims, cause of action, or liability to any other person arising from my participation in the activity listed above;
3. Consent to receive any medical treatment deemed advisable in the event of injury, accident or illness during these activities; and,
4. Agree that any claim or controversy involving this Waiver of Liability and Indemnification Agreement shall be brought solely in the District Court of Pipestone County, Fifth Judicial District, State of Minnesota.
5. I am aware of and agree to abide by the Range Rules as established by the Pipestone Sportsmen’s Club
6. If applicable and by my signature, I understand I am responsible for any shooter age of 18 and under in my household or accompanying party.

I HAVE READ THIS ASSUMPTION OF RISK, WAIVER OF LIABILITY AND RELEASE AGREEMENT, AND INDEMNIFICATION AGREEMENT, AND I FULLY UNDERSTAND ITS TERMS. I FUTHERMORE UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING THIS DOCUMENT AD I HAVE SIGNED IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT, ASSURANCE, OR GUARANTEE BEING MADE TO ME. I INTEND AND I FULLY UNDERSTAND THAT THE EXECUTION OF THIS AGREEMENT CONSTITUTES A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIBILITY TO THE GREATEST EXTENT ALLOWED BY LAW.

Pipestone Sportsmen’s Club reserves the right to refuse use of the facility to anyone at its discretion.
