- Water Shed report from Dale Pavlis who attended the meeting last month at Key Largo. –He came away with learning that it was good the City adopted the water/sewer system when we did. Costs have gone up; the demand to make these updates has increased by the state. One

take away was how we take advantage of the water and not respect it – such as: Water is meant to evaporate; many things we do changes the dynamics about water.

- Do we need to survey of Boundary's for alley to establish right of way before the cement is poured? Rick will contact Sharon Johnson to see about an easement at the property before proceeding. Dale will contact a surveyor for a cost.
- It was suggested to install fiberglass posts to the Halbur and Brands properties to make sure to maintain the property boundaries.
- City of Hadley property and liability insurance \$16002.00 due by 4/1/18.
- Rick met with Randy Groves regarding County Road 29. They discuss how it would take shape and what would be added and removed; Randy said it would be in 2020 or 2022. It would involve replacing the road way; sidewalk, curb and gutter; possibly adding a walking trail by the lake; widening out the road way; the parking in front of the bar would possibly change to be parallel parking .
