Review of August Minutes: Minutes are approved.

Review of Liquor Fund: The compressor in the small cooler behind the bar was replaced. The A/C in the pool room has been kicking off the breaker and it would cost \$6000 to replace the A/C. It would cost \$8600 to replace the 2 A/C units in the bar. The toilets that were replaced are power flush and not auto flush. The liquor fund is approved.

Review of the General Fund: We will pay the County the permit cost shared with the County for the work to be done by Johnson Ditching.

Review Water/Sewer Fund; Judy will contact a couple of aged balances and the other aged balances will be added to the property taxes.

Old Business:

- Review of ordinances with Merlyn - 18-001 Regulated Open Burning to set fine. This is a misdemeanor which needs fines applied: MSP by Dale & Henry - 1st & 2nd Offense \$300 each and 3rd Offense \$500. 18-002 Regulated Parking – 18-003 – Regulated exhibition driving and 18-005 –Regulating Cats & Dogs, these are all Petty Misdemeanors and the fines are set at 1st & 2nd Offense at \$100 and 3rd offense at \$300. 18-004 Regulating Public Nuisance MSP by Dale & Henry 1st & 2nd Offense \$300 each and 3rd offense at \$300. MSP by Dale & Henry to recommend each ordinance by made as a payable either in person or by mail. It would seem this would go to the county and it would subsequently be reimbursed to the City.
- The Flushing of the water system is tentatively scheduled for Friday September 21st. Judy will contact the radio station regarding the Water Flushing. Rick will ask Darren about the time of day he will be able to do the flushing.
- Judy will send a Certified Letter to Teresa Hughes regarding the dead tree on her property.
- Rick working with Rebecca Townes regarding making Park & Rec a non profit.
- Dale Is wondering again about redoing the bathrooms with new paint and updating them.

New Business:

- Bonnie was going to talk to Gordy Swan about snow blowing Summit Lane. Bonnie is not here to let us know the outcome.
- There is a dog in the area that is continually barking in the evening. There have been other dogs loose in town as well according to another homeowner. Dale was contacted by a couple of residents and spoke with the owner of the dog to let him know of the disturbance. The dog owner deflected the situation and stated other dogs are loose in town. Rick has suggested possibly put together a standard letter. Henry has suggested maybe two council people should visit the dog owner.

- Henry talked about repairing the service door on the city garage and he is not able to locate the trimmer. Henry will ask Walt Kautz to repair the door. Henry will also talk to Brycen to keep the building tidy.
