The meeting was called to order by Mayor Like at 6:05 pm.

Truth in Taxation meeting with Marci Barritt, Jean Nelson, Amber Hanson from the County. There were no sales in the City of Hadley in 2015. Merlyn Anderson needs to annex the site where the new bin was constructed by the Elevator. Once the site is annexed from the township to the City the tax will then come back to the City. M/S/P by Henry and Dale to accept the information provided regarding the property taxes.

Rick Like at this time is the only person training certified to hold the Truth in Taxation meeting.

Review of Water/Sewer Fund- Judy will turn the invoice for the water pump motor that was repaired. We have a couple of people that are late on paying; their water will be shut off.

Old Business:

- Bonnie asked Haken's for an estimate for the repair of the ceiling and the air conditioner. They repaired the ceiling and removed the drip pan on the A/C as it is deteriorating. Parker has looked at the A/C and is recommending replacing the A/C at \$3500 - \$4000. The system sits in the ceiling and cools the council room, the hallway and the kitchen. Rick will ask Parker if a unit for heating and cooling would be available. M/S/P by Dale and Nick to replace the A/C and add a heating unit with it.
- Vehicles for veterans – operates under 4 different names and we will not include it on our website.
- Letter to the County regarding the Culverts....Rick will work on for next month.
- Gravel was hauled in but not delivered correctly. We will have them deliver more for the lift station and also is needed at the recycling center.
- Streets – Nick had estimates for paving from Rick Likes place to Nick Pieske place for \$25k. The next estimate was for 2nd, 3rd, 4th and East 2nd street \$19K with one year warranty. There is also a possibility of working with the state since they are doing Hwy 30 to see if they would do some work in Hadley. Nick will make that call to see what the likely hood would be to do so.
- Signage is on hold.

- Clean up day? Rick and Bonnie will work with Judy regarding Clean up. Judy will send a certified letter to the family that has garbage sitting out and not getting emptied that we will turn it over to the county as a health hazard.
- Judy will send the invoice for the pump repair to the Insurance company.
- Chris Hanson – comprehensive water plan – Dale
- Judy – move information from the Water/Sewer computer to the main computer.

New Business:

- Ball Park – Rick will talk to the Lyons about some repairs at the ball park – the bathrooms and the playground equipment.
- Mowing- Henry will mow the park and Carol will clean the restrooms at the ball park.
- Who cleans the bathrooms in the bar?
