E.K.'s Vinyl Structures LLC Limited Warranty

E.K.'s VInyl Structures LLC makes the following limited warranties on new heavy duty and economy buildings. These limited warranties extend to the original purchaser and to no other purchaser or transferee.

LIMITED 30 YEAR ON HEAVY DUTY AND 15 YEAR ON ECONOMY

E.K.'s Vinyl Structures LLC warrants this product against defects in materials or workmanship for a period of 30 years heavy duty, 15 years economy after the date of installation. E.K.'s Vinyl Structures LLC also warrants that the shed substantially conforms to the quality and workmanship of the display shed of the same model which may have been shown to you by the authorized E.K.'s Vinyl Structures LLC dealer who sold the shed to you. During the period of this warranty E.K.'s Vinyl Structures LLC will repair a defective or nonconforming product or part without charge to you. This limited warranty extends only to defects in material or workmanship as limited above and does not extend to any product or part which has been lost or discarded by you or to your shed caused by misuse, accident, improper maintenance, or improper use, vandalism, or acts of God, including but not limited to tornadoes, hail and floods, or to units which have been altered or modified without the written permission of E.K.'s Vinyl Structures LLC.

YOUR RESPONSIBILITY

The above warranties are subject to the following conditions:

- 1. You must retain your bill of sale or provide other proof of purchase.
- You must notify E.K.'s Vinyl Structures LLC at the address shown in the step-by step procedures within thirty (30) days after you discover a defect in your shed.
- 3. All warranty servicing of the product must be made by E.K.'s Vinyl Structures LLC or its agents.
- 4. This warranty is effective only if the product remains at the site where originally constructed or delivered by E.K.'s Vinyl Structures LLC or the authorized dealer, as applicable.
- You must perform adequate routine maintenance on the shed including painting, leveling adjustments and keeping vegetation from growing around the edges of the shed.
- 6. Any building over 10'x12' must be set up properly on a pad of 2a stone, or a concrete pad. Cinderblocks may be used for any building 10'x12' and under. Concrete pad must not be any larger than base of shed.
- 7. Do not set anything against the exterior of your building.

Your failure to meet your responsibilites as outlined above or failure to follow the warranty procedures as set forth below will void this limited warranty.

Step-by-Step procedures to obtain warranty service

To obtain warranty services you should:

1. Contact E.K.'s Vinyl Structures LLC at 816 East Valley Road, Loganton, PA 17747 within thirty (30) days after you find a defect in your shed. You must provide a copy of the bill of sale or other proof of purchase and written description and picture of the defect to E.K.'s Vinyl Structures LLC within the thirty (30) day period.

ALL WARRANTIES IMPLIED BY STATE LAW, INCLUDING THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE ARE EXPRESSLY LIMITED TO THE DURATION OF THE LIMITED WARRANTIES SET FORTH ABOVE. SOME STATES DO NOT ALLOW LIMITATIONS ON HOW LONG AN IMPLIED WARRANTY LASTS, SO THE ABOVE LIMITATION MAY NOT APPLY TO YOU. WITH THE EXCEPTION OF ANY WARRANTIES IMPLIED BY STATE LAW AS HEREBY LIMITED. THE FOREGOING EXPRESS WARRANY IS EXCLUSIVE AND IN LIEU OF ALL OTHER WARRANTIES, GUARANTEES, AGREEMENTS, AND SIMILAR OBLICATIONS OF THE MANUFACTURER OR DEALER WITH THE RESPECT TO THE REPAIR OR REPLACEMENT OF ANY PRODUCT OR PARTS.
