Section 4. First aid measures

Description of necessary first aid measures

Methods and materials for containment and cleaning up

Precautions for safe handling

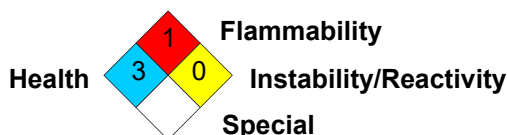
