COUNCIL RESOLUTION NO. 2026-03**

**A RESOLUTION TO APPROVE PURCHASE ORDERS OVER
\$25,000.00**

WHEREAS, pursuant to ORC 5705.41 (D) (1), no subdivision shall make any contract or give any order involving the expenditure of money unless there is attached thereto a certificate of the fiscal officer of the subdivision:

WHEREAS, Requisition requests over \$25,000.00 require authorization by Resolution by the Council of Village of New Miami;

NOW, THEREFORE, be it resolved by the Council of the Village of New Miami that:

Section 1: The Council does hereby approve the request described in the list which is attached to the resolution and made a part hereof, and authorizes the Fiscal Officer to approve said requisitions on behalf of the Council of the Village of New Miami.

Section 2: This Resolution shall go into effect retroactively to January 1, 2026

Section 3: It is hereby found and determined that all formal actions of this Council and any of its committees concerning and relating to the passage of this legislation were adopted in open meetings, in compliance with all legal requirements, including Section 121.22 of the Revised Code of Ohio.


